

**BOXER CITRUS COMPETITION
TERMS & CONDITIONS**

1. The promoter is Boxer Superstores (Pty) Ltd ("the Promoter").
2. The promotional competition is open to all Boxer stores within South Africa including eSwatini.
3. This promotional competition is open from 23rd June to 10th August 2025. Any entries received after the closing date will not be considered.

 - b. RSA - Swipe your Boxer Rewards Club Card for automatic entry
 - c. Eswatini – SMS 'Citrus', your name, store name & unique number to 11111
