

**BOXER IPHONE COMPETITION
TERMS & CONDITIONS**

1. The promoter is Boxer Superstores (Pty) Ltd ("the Promoter").
2. The promotional competition is open to all Boxer stores within South Africa excluding eSwatini.
3. This promotional competition is open from 24th July to 21st September 2025. Any entries received after the closing date will not be considered.

This competition is open to all residents of South Africa who are 18 years or older, in possession of a valid identity document, except any director, member, partner, employee, or agent of Boxer, or any person who directly or indirectly controls or is controlled by these entities, including their spouses, life partners, business partners or immediate family members.
5. The entry mechanism for the competition is:
 - a. Buy any two advertised Shield, Axe or Dove Deodorants / Roll Ons;
 - b. Swipe your Boxer Rewards Club Card for automatic entry
