

BOXER & NESTLÉ COMPETITION 2026
TERMS AND CONDITIONS

1. INTRODUCTION

1.1. Participation in the Boxer & Nestlé 2026 Competition (“the Competition”) is governed by these Terms and Conditions (“Rules”).

1.2. By participating in this Competition, all entrants confirm that they have reviewed, understood, and accepted these Rules in full.

1.3. The Competition is jointly promoted by Boxer Superstores (Pty) Ltd and Nestlé (South Africa) (Pty) Ltd (collectively referred to as “the Promoters”).

2. ELIGIBILITY AND ENTRY REQUIREMENTS

2.1. The Competition is open to all natural persons who are legal residents of South Africa, aged 18 years or older, and in possession of a valid South African Identity Document or Smart Card.

2.2. Exclusions: Directors, members, partners, employees, agents, or consultants of the Promoters, or any persons directly or indirectly controlling or controlled by the Promoters, as well as their spouses, life partners, business partners, or immediate family members, are excluded from participating in this Competition.

2.3. The Competition runs from 00:01 on 7 September 2026 to 23:59 on 7 October 2026 (“Competition Period”). Any entries received prior to or after this period will be automatically disqualified.

2.4. To enter, a participant must:

a. Purchase any two (2) participating Nestlé Chocolate products (Bar-One, KitKat, Tex, Smarties, Milkybar, Aero, or Peppermint Crisp) in a single transaction from any participating Boxer store; and

b. Swipe their valid Boxer Rewards Club card at the till point during checkout to automatically record the entry.

2.5. Participants may enter multiple times, provided that each entry is associated with a qualifying, separate purchase transaction.

3. PRIZES AND WINNER SELECTION

3.1. The Prizes consist of:

a. Grand Prize: One (1) x Trolley Dash to the maximum value of R5,000.00 in store goods, hosted at a designated Boxer store. This prize cannot be exchanged for cash.

Trolley Dash Terms: The specific date, time, and Boxer store location will be coordinated directly between the Nestlé team, Boxer store management, and the confirmed Grand Prize winner. A 2-minute trolley dash will take place where the winner will aim to place as many products into the trolley within the time frame.

b. Runner-Up Prizes: Fifty (50) x 1,000 B Rewards (credited directly or sent via SMS to the winner's registered mobile number).

B Rewards Terms: B Rewards are redeemable only for store purchases at participating Boxer stores and cannot be exchanged, transferred, or redeemed for cash.

3.2. Winners will be selected at random using an automated, system-generated draw. Winners are not allocated by individual store location; therefore, not every Boxer store will have a winner.

3.3. 3-Month Winning Exclusion Rule: Participants who have won any prize in a Boxer competition within the three (3) months prior to the draw date are ineligible to win. The 3-month exclusion window begins on the exact date the participant was previously drawn as a winner. If a selected entrant is found to have won within this timeframe, they will be disqualified, and an alternative winner will be drawn.

3.4. All winners will be drawn and announced on or before 23 October 2026.

4. GENERAL TERMS AND LIMITATIONS OF LIABILITY

4.1. The Promoters reserve the right to substitute any prize (or portion thereof) with an alternative prize of comparable or greater commercial value if circumstances require.

4.2. The Promoters' decisions on all matters pertaining to the Competition are final and binding, and no correspondence or negotiation will be entered into.

4.3. The Promoters, their advertising agencies, suppliers, and partners accept no responsibility for lost, late, incomplete, corrupt, or failed technical submissions, network outages, or hardware errors that prevent an entry from being registered.

4.4. All Participants participate entirely at their own risk. By reading and accepting these Rules, the Participants give consent to these risks and hereby indemnifies and holds harmless the Promoters, their directors, employees and agents of any and all liability pertaining to any damage, cost, injuries and losses of whatever nature sustained as a result of their participation in the Competition and related events and activities, save where such damage, cost, injuries and losses are sustained as a result of the gross negligence or willful misconduct of any of the Promoters.

4.4. Publicity and Image Rights: By participating in the trolley dash, the Winner grants the Promoters the right to film, record, and photograph the trolley dash. Furthermore, all Winners may be invited to allow their names, photographs, and video footage to be published on the Promoters' official social media channels, websites, or print materials for promotional purposes without compensation. Winners maintain the right to decline or withdraw consent to participate in publicity activities.

4.5. Data Protection (POPIA): By entering this Competition, participants acknowledge that their personal details will be processed by the Promoters solely for the purpose of administering this Competition, verifying winner identity, and issuing prizes, in compliance with the Protection of Personal Information Act 4 of 2013 (POPIA) and Boxer's Data Privacy Statement.

4.6. Force Majeure and Cancellation: The Promoters reserve the right to amend, suspend, or terminate the Competition immediately and without prior notice due to unforeseen circumstances beyond their reasonable control. In the event of such termination or variation, all entrants waive any rights or claims they may have against the Promoters.

4.7. Neither the Promoters, their affiliates, nor their employees, agents, or partners shall be held liable for any direct, indirect, incidental, or consequential loss, injury, or damage suffered by any entrant or winner in connection with their participation in this Competition or acceptance and use of any prize.
