

**BOXER AND TYMEBANK R1000 BOXER ECOUPON COMPETITION TERMS AND  
CONDITIONS**

The winners will be determined by way of a random audited draw to take place on 01 June 2023.
- 3.4 In order to qualify for this promotional offer:
- 3.4.1 the participant must be a South African resident
- 3.4.2 the participant must provide correct and full personal details, as required
- 3.4.3 the participant must be 18 years old or older

- 3.4.4 the participant must be a natural person;

- 3.7 The Boxer eCoupon can only be redeemed in any Boxer Superstore nationwide
- 3.8 The voucher is valid until 29 February 2024.
- 3.9 The Boxer eCoupon will not be negotiable, transferrable, deferrable or capable of being exchanged for any other item or cash.
